BACKGROUND

The City of Biloxi, MS is located in Harrison County along the Mississippi Sound, which is separated from the Gulf of Mexico by a series of barrier islands. Biloxi's coastal location and waterways, including Biloxi Bay, the Back Bay of Biloxi, and the rivers and streams that flow into them, shape the culture and heritage of the region. The City is about 46.5 square miles, of which 82% is land and 18% is water. Municipalities and jurisdictions adjacent to Biloxi include the City of Gulfport to the west, unincorporated Harrison County to the north, and the City of D'Iberville to the northeast. It is part of the larger Gulfport-Biloxi Metropolitan Area, which includes three counties: Hancock, Harrison, and Stone.

With a prior history of hurricanes and a high average annual rainfall ranging between 55 and 64 inches, the city of Biloxi can regularly experience flood events. To address this concern, city leaders and staff have taken a number of steps over the years to plan and prepare for flooding. In 1970, the city of Biloxi enrolled in the National Flood Insurance Program and in 2002 the city became a member in the Community Rating System. Currently, the city maintains a class 5 CRS rating, which means that Biloxi flood insurance policy holders in the Special Flood Hazard Area receive a 25% discount on their premiums. The city of Biloxi is also a member of the Coastal Hazard Outreach Strategy Team (CHOST), a CRS Users Group founded in 2008 to foster regional cooperation on flood communication and messaging along the Mississippi Gulf Coast.

PROJECTS REVIEW

Through the process of developing the PPI, the Committee developed projects aligned with the six required CRS messages, as well as two additional messages outlined in the document. Over the course of the PPI development process, the committee identified 12 target audiences to whom the outreach messages should be delivered. The first six messages are a requirement of the CRS program. By developing a PPI program, the city of Biloxi is able to develop additional outreach messages which are shown in this document as seven through eight.

- 1. Know your flood hazard
- 2. Insure your property for your flood hazard
- 3. Protect people from the flood hazard
- 4. Protect property from the flood hazard
- 5. Build responsibly
- 6. Protect natural floodplain functions
- 7. Prepare for hurricanes.
- 8. Be prepared for emergency events common is this region, including flooding.

ADDITIONAL PROJECTS INFORMATION


With concerns regarding the COVID-19 Pandemic still high this year, it has been difficult to resume normal flood outreach events and activities. For example, in lieu of the usual R U Ready in-person event, city staff created an R U Ready Youtube video for the 2021 hurricane season detailing different flood concerns residents need to be mindful. In addition to this, Biloxi staff also participated in a Severe Weather Awareness Expo organized by MS-AL Sea Grant on June 26th. In 2021, the PPI Committee added the following outreach projects to the project inventory.

- BNews monthly newsletter:
 - The city's monthly newsletter will become the primary outreach method for notifying all Biloxi residents of flood concerns and upcoming flood outreach events. Flood messaging within the newsletter will generally occur in the months of May and/or June to coincide with the start of the Gulf hurricane season.
- R U Ready Youtube Video:
 - The <u>42-minute Youtube video</u> goes over basic flood precautions and measures city residents need to take as hurricane season begins.

In addition to this activity, another outreach venture was added in 2019. To promote the use of living shorelines as a natural flood mitigation alternative, a brochure was produced by Mississippi-Alabama Sea Grant. The brochure describes the benefit of natural systems to flood protection and mitigation and draws attention to living shorelines installed within the Biloxi area.

- Living Shorelines Brochure:
 - This short brochure is publicly available at the front entrance to the city's Community Development Building and includes important information on natural options available for flood protection and the value of natural systems to city flood protection.
- Living Shorelines Interpretive Signs:
 - As part of an EPA Grant Project, Biloxi staff worked with MS-AL Sea Grant and other coastal agencies to develop interpretive signs highlighting living shorelines projects. Two of these projects are located within the city and can be accessed by the general public. These signs enhance city flood outreach by highlighting coastal restoration practices and how natural systems can be enhanced to provide protection from coastal erosion and flooding.

Map of first floor elevations for buildings in Biloxi, Mississippi. This map depicts the elevations of 1250 buildings.


In order to improve the city's flood outreach, the Community Development Department has engaged with a wide variety of stakeholders to secure grant funds and participate in research that will help the city in understanding its flood risk to the fullest extent possible. In 2019, the city received grant funding from PLACE:SLR to conduct a flood study that would use Google Streetview data to determine the finished first floor elevations of properties within Biloxi's economic development district. Hal Needham, with CNC Catastrophe & National Claims, produced a comprehensive elevation database of 1,250 buildings in and around's Biloxi's Economic Development District. Additional information obtained through this study includes high water mark data from 35 storms and flood frequencies under different future sea level rise scenarios.

Though some of the data will be used for internal purposes only, the impact this information will have on Biloxi flood outreach is significant. With first floor elevation data in hand, Biloxi staff will have the ability to employ a more targeted approach to flood outreach as they will be able to identify small pockets of properties where elevations are low and out of compliance. The city can also identify properties where minor retrofits may be highly advantageous and bring a property into full compliance with BFE requirements. This will be advantageous should the city pursue disaster mitigation funds in the future. Additionally, Hal Needham will produce some outreach products to promote the use of the data and its value to Biloxi homeowners. A longer video to promote project data to elected officials will also be completed.

CURRENT VS. FUTURE FLOOD RISK

Many factors influence flood risk. The type of flood, the timeframe being considered, development patterns, sea level rise, and natural cycles can all influence flood risk. It is important to note that flood risk maps are often looking at a snapshot in time. Being located adjacent to a floodplain or building to the base flood elevation of a floodplain does not mean that the property is not at risk to flooding. Flood risk can change on the order of years to decades, depending on what is occurring in the area.

In order to have a robust flood communication process, the city of Biloxi continues to reach out to regional partners and stakeholders in order to better understand how the city's flood risk may evolve over time. Regional stakeholders such as PLACE: SLR, MS-AL Sea Grant, the Mississippi Chapter of The Nature Conservancy and the Grand Bay National Estuarine Research Reserve are valuable local partners in helping assess future flood risk. In the past, Biloxi has used regional tools, such as the NOAA Sea Level Rise Viewer, at various expos and public outreach events to inform city residents that flood risk is not static and may fluctuate over time due to factors such as sea level rise and coastal erosion.



Sea Level rise data provided by the Northern Gulf of Mexico Sentinel Site Cooperative indicates that the city of Biloxi may see between 2.0 to 3.6 feet of sea level rise by 2060.

OUTREACH PROJECTS

In 2021, a significant change was made to the city's outreach approach to improve message delivery and flood communication. The major change to Biloxi's flood outreach has been the incorporation of BNews into the city's overall flood outreach plan. In the past, city flood communication was accomplished primarily through mailers to city residents. Though some mailers to specific audiences are still delivered, the use of mailers has been curbed in favor of regular flood messaging in BNews. For example, Biloxi's City-Wide Flood Mailout and Floodplain Resident Mailout were discontinued in favor of regular updates and notifications in BNews. BNews is a monthly newsletter produced by the city, which goes out to all Biloxi residents. The advantages of this process are that flood messaging is better integrated into the city's regular communication process and, furthermore, because BNews is monthly, flood outreach can be targeted during times of the year where flood concerns are high, such as the start of hurricane season.

Went over PPI document:

Stephen Deal shared the updated PPI document with the committee through Zoom. A few additions were made to provide additional clarity on the city's flood outreach approach and how the PPI related to other CRS activities implemented by Biloxi staff. One section entitled "Other Ongoing Public Information Efforts" showed flood outreach activities conducted by agencies or organizations besides the city. A separate section entitled "Outreach Activities Subject to CRS" made note of how the Program for Public Information will be used to publicize and manage other CRS activities.

Also, some minor changes had to be made to the PPI project inventory to include new activities and changes to the city's public notification process. These new sections and changes to the project inventory were reviewed by the committee and approved for use within the document.

Discussion on New Outreach Projects to Consider Incorporating in the Future:

After the document changes were reviewed and approved, there was some discussion about potential new outreach the city might pursue in the future.

Rick – Might be a good idea to do some outreach venture on Risk Rating 2.0.

Committee members were asked whether they had any ongoing events, such as education courses or flood mitigation outreach, that might be worthy of inclusion in the document. No additional events were brought forward by committee members at the meeting.

Discussion of Changes Associated with Risk Rating 2.0

Mr. Ross Maxwell (insurance)

- 1. Under Risk Rating 2.0 properties are being evaluated on a host of criteria for their specific property rather than just receiving a rate based on their zone. These are the same criteria we learn about on FEMA's webinars (foundation type of the structure; height of the lowest floor of the structure relative to base flood elevation; replacement cost value of the structure; a broader range of flood frequencies and sources (heavy precip, coastal erosion outside V zone); geographical variables the distance to water, the type and size of nearest bodies of water, and the elevation of the property relative to the flooding source.
- 2. He gave an example where he quoted two homes, both in the AE zone, with varying premiums (\$625/year for one and \$3,900/year for the other)
- 3. He is having a lot of luck writing private market flood policies. There is no cap on the coverages. He has seen policies go from \$2,100 in the NFIP to \$700 per year in the private market.
- 4. Although FEMA is doing away with grandfathering, it is really just now being called statutory discounts.
- 5. He quoted one person a policy for \$2,800 without an elevation certificate, then with the EC it went to \$900.
- 6. The client does not have to have an EC, nor do they have to pay for one. FEMA is allowing a homeowner to complete sections (a) and (d) on pages 1 & 2 on their own and sign off on it. They will accept this to quote a new rating. They are looking at the lowest floor vs. lowest adjacent grade (LAG). This helps them to determine the specifics of the structure such as: Is it in an X-zone but has a lot of back-fill? (for example)
- 7. A "nightmare scenario" is what will happen to those clients who allow their flood insurance to lapse. These policies will be higher.
- 8. Right now there is a cap on policies that are not at full risk rate of 18% each year. FEMA can change this but he does not see how it could realistically go much higher.
- 9. The 18% max rate increase premium will build over time for properties at lower elevations until they reach full risk-based rates.
- 10. So far, Ross has not written any policies with greatly increased rates. In most cases, the amount has gone down and/or he has found a private market policy at a lower rate for his customers.

Mr. Tommy Luke (resident)

- 1. Resident has a home on Eagle Point in Biloxi in the V zone. When he built the house he was at a V14 but with the current maps is at a V18. He uses AllState Insurance.
- 2. His agent put his home in the system without an elevation certificate and it went from \$2,000 to greater than \$5,000. He put it in with the EC and the amount was \$300 less than what he is paying (\$1,700). Once the system saw there were no enclosures or obstructions, the cost went down.

3.	Also he has an electrical junction box that is below the BFE. This effected his rate but is an easy and inexpensive thing for him to move.
